Interest-Free Finance for Street Lighting Upgrades

Salix is a not-for-profit, government funded organisation, dedicated to providing interest-free finance for public sector energy efficiency projects. Salix has provided over £190 million towards 81 English local authority street lighting projects. These projects have delivered annual savings of £36 million and 130,000 tonnes of carbon.*

How does the funding work?

- Interest-free loan based only on estimated energy savings.
- Other savings such as maintenance or carbon tax are additional benefits, not included in the loan.
- Finance can be reserved in advance of procurement, PFI changes and council approvals to support the decision making process.
- Salix funding can enable councils to accelerate existing conversion programmes to realise savings sooner.
- Flexible finance allows for project changes during development and delivery.
- The loan repayment term is five years. Projects which span financial years have a staggered repayment schedule.
- Repayments start at least six months after each year completes.
- Repayments are recycled to benefit other energy efficiency projects.

Nottinghamshire County Council Case Study



Nottinghamshire County Council has been working with Salix since 2008 on energy efficiency projects across their corporate estate.

Between 2015 and 2018 the council delivered a large-scale LED street lighting upgrade. Nottinghamshire used a £7.2 million interest-free Salix loan to convert 45,000 street lights to LED, accounting for almost half of the street lights in the county.

Nottinghamshire worked in partnership with Via East Midlands Ltd to replace the existing SOX street lights with efficient LED lanterns achieving a 60-70% reduction in kWh consumption. The project has also benefited residents by providing improved lighting to roads and footpaths. The council are now looking to work with Salix to convert its remaining street lights to LED.
